a. Master in International Affairs:

b. Master in Public Policy:

For young professionals with 2 to 5 years of work experience, the 2-year Master in Public Policy (MPP) is a suitable programme to provide an in-depth training in policy analysis, economics, research and statistics.

c. Master in Public Administration:

For mid-career/ middle management professionals with 5 to 10 years of work experience, the 1-year Master in Public Administration (MPA) programme to develop skills in leadership and creative thinking and problem solving is offered.

2. The details about the aforesaid LKYSSP's Master Programmes is attached for reference. Admission in the programmes and scholarships are offered on competitive basis.



For example, students who had previously enjoyed subsidies/scholarship in a Master programme and had attained the Master degree will not be eligible for subsidies in another programme at Master or lower level.
