It is once again reiterated that no Officer Trainee will be allowed to appear for any examinations conducted by UPSC/State Public Service Commission during their basic training period at NACIN. Also During this period, no Officer Trainee will be allowed to appear for any Public Service Examination.

Any Officer Trainee who desires to proceed on EOL is directed to join on **18.12.2017 at 9:30AM** for completing of joining formalities etc. It is further clarified that all Officer Trainees, who will be proceeding on EOL shall be relieved immediately once their joining formalities are over, in all likelihood on 18.12.2017 itself. A Special Table has been earmarked for such OT's to facilitate the joining at NACIN on 18.12.2017.

Only the original documents relating to educational qualification, category/Caste etc. shall be verified on 18.12.2017.
