**Subject:- Two (2) days National Training Course on Drug Law Enforcement from 18<sup>th</sup> to 19<sup>th</sup> September, 2018-reg.**

The National Academy of Customs, Indirect Taxes and Narcotics (NACIN), Faridabad is the designated Nodal Agency for training in the area of "Drug Law Enforcement" by Government of India. Accordingly NACIN, Faridabad is organizing "National Training Course/Workshop on Drug Law Enforcement" for officers of Central Board of Customs and Indirect Taxes (CBIC) and other law enforcement agencies from **18-19 September, 2018**.

The two (2) days Training course is being organized to cover, inter alia, various aspects relating to recent legislative and regulatory changes on Narcotics Drugs, Psychotropic Substances and Precursor Chemicals. It will also cover the topics of emerging new psychoactive substances, Financial Investigation and Money Laundering in context of narco trade, Special Investigation Techniques, undercover operations and controlled delivery etc. The course content is not only relevant for officers posted in enforcement of NDPS Act & other Allied Acts, but also GST and Customs Officers who are involved in assessment and Classification of Chemicals, Pharmaceutical drug etc.

3. It is requested that **suitable officers of the rank of Assistant/Deputy Commissioners and above** under your zone/charge may be nominated for participating in the above course.



Nomination received after 03<sup>rd</sup> September, 2018 may not be accepted.
