National Academy of Customs, Indirect Taxes and Narcotics, Faridabad is organizing a **Four-Days' Refresher Training on GST from 30<sup>th</sup> July, to 2<sup>nd</sup> August, 2019** for Group 'A' Officers of CBIC.

2. Since GST rollout, numerous changes have been brought about in the new regime keeping in view the requirements of both taxpayers and departmental officers. In view of such regular changes, need for a refresher training course on GST assumes a great importance. Hence, NACIN, Faridabad is organising this Four-Days' Refresher Training for CBIC Officers. At the end of the training, participants will have a fresh over view of GST Laws, its fundamentals and CBIC-GST Front-End and Back-End Applications. They will also be walked through important aspects like registration, returns, assessment, audit, E-Way Bill System, refunds, input tax credit, TDS / TCS, inspection, search, seizure and arrest, offences & penalty, demand & recovery, advance ruling, Anti-Profiteering provisions, various MIS reports and Dashboards available in the application.

3. It is, therefore, requested that suitable Group 'A' officers, may be nominated for participating in the above course.

5. It is, further, requested that hard copy of nomination **may not be sent** separately through courier or by post so as to avoid wastage of paper.


6. It may kindly be ensured that the officer once nominated should attend the training course as last minute cancellation/withdrawal results in considerable administrative and financial issues.

7. It may be mentioned that limited hostel facilities are available for the participants, who wish to stay in campus. For the participants, the hostel and mess charges (all inclusive) shall be approximately Rs. 400/- per day. This includes Rs. 100/- room rent, Rs. 100/- Breakfast + bed tea, Rs. 200/- for dinner. Rs. 250/- for lunch and tea/snacks (twice a day) is to be paid separately at the time of registration by all the participants.
