## VACANCY CIRCULAR

To  
All Zones of CGST / Customs / Directorates under CBIC

Madam / Sir,

Subject:- Vacancy Circular – Calling for willingness for the post of **Tax Assistant (TA) on deputation basis** in the Zonal Campus of National Academy of Customs, Indirect Taxes & Narcotics (NACIN), Shillong -reg.

Application of willing officers are invited to fill up **one (01) post of Tax Assistant (TA)** on deputation basis in NACIN, ZTI, Shillong from amongst the Officers holding analogous posts in the formations of CGST/Customs/Directorates under CBIC.

2. The period of deputation is initially for a period of three years and can be further extendable by two years (one year at a time) at the discretion of the competent authority in concurrence with the cadre controlling authority concerned. Only officers with minimum service tenure of three years are eligible to apply. It may be noted that the final selection /appointment is subject to clearance from the prospective candidate's Cadre Controlling Authority (CCA).

3. The candidate so selected for deputation against the above post will be eligible for Deputation Allowance as per extant instructions. Officers getting deputation allowance shall not be eligible for honorarium at NACIN. The selected candidate will have to make his/her own arrangement for residential accommodation.

4. It is to mention that once a candidate is selected based on their willingness, he/she will not be allowed to withdraw their candidature and are expected to serve at NACIN, ZTI, Shillong till the expiry of the deputation period.


5. In case while working in NACIN, ZTI, Shillong, if the conduct and/or work of the officer is found to be not satisfactory, the officer will be liable to be reverted back/repatriated to the parent CCA before completion of loan period without assigning any reasons thereof.

6. Applications of interested and eligible officers may kindly be forwarded to NACIN, ZTI, Shillong by **31.08.2022** in the proforma mentioned in the Annexure-1 along with Vigilance Clearance Certificate, No Objection Certificate from the CCA and APAR grading for the last five years.

7. It is requested to widely circulate this vacancy circular amongst the officers under your charge.
